

#### CHAPTER 1 A HISTORY OF CORRUPTION AND EXPLOITATION IN NIGERIA 1914 - 2022 (108 years)

The year is 2022 and at this time, the NIGERIA economy has collapsed like a pack of cards under the weight of heavy duty artillery corruption and bad governance.

The history of Corruption in Nigeria dates back to 1914, about 108 years ago, when the North and South Protectorates were merged into one nation called NIGERIA in the great amalgamation, thereby creating a new Nation called NIGERIA. The name NIGERIA was given to us by a white woman who happened to be the Mistress to Lord Lugard and the name NIGERIA was inspired by the River Niger that flowed through a vast territory of NIGERIA, before reaching the South Atlantic ocean, where it empties in a dramatic web of estuaries and rivers known as the Niger Delta region.

On careful reflection, it really baffles me why our post Colonial leaders like Nnamdi Azikiwe, did not see it fit to discard the name NIGERIA, given to us by the wife or Mistress of a colonial Governor, Lord Lugard, who was serving in a colonial territory as Governor General at the instance of King George V of the British Empire.

There are however a good number of nations in Africa that changed the names Colonial Masters gave them to fresh names, inspired by the unique nationalism of the respective Nations.

Ghana was called the Gold Coast during colonial era. Rhodesia is now known as Zimbabwe. And there are other examples. We do not need anybody to tell us that Ghana is now flying in the

skies, while Nigeria is crawling on her belly. Could name change from Gold Coast to Ghana have been a factor in Ghana's prosperity and stability? Only God knows all.

There are Spiritual significance of retaining old names or garments when a new identify is assumed, because the proper thing our post Colonial leaders should have done is to give NIGERIA a new name in recognition of her new found status as an independent nation.

This may very well have arrested and changed the course of corruption and exploitation of our great human and natural resources that NIGERIA was plunged into by the exploitation of an entire nation by the British Empire which has continued till this day in new dimension of people of a nation exploiting each other.

In Bible stories we see what Blind Bartimaeus did when he regained his sight after Jesus healed him of blindness. Bartimaeus simply tore to pieces his old garments and put on fresh new garments, because he had suddenly regained his sight. One should not retain an old garment of slavery, exploitation or indeed any other form of bondage when a new identify has manifested.

### Blind Bartimaeus (Mark 10: 46-52)

Jesus was leaving Jericho, followed by a large crowd, on his way to Jerusalem when he came across a blind beggar called Bartimaeus. After Bartimaeus regained his sight by divine healing, he immediately tore his tattered garments of bondage by blindness and immediatelyput on fresh new garments. This is exactly what our post Colonial Leaders should have done when NIGERIA became an Independent Nation in 1960 because this simple exercise of discarding old garments has deep spiritual significance to the trajectory the nation may have followed.

To help ascertain the importance and great spiritual significance in name or identify change, let's visit the scriptures again.

The scriptures tell us how God Almighty Himself changed the name of Abraham. Before this change of name, Abram was the name of Abraham so when God decided to make in Abram a great nation, God changed his name from Abram to Abraham.

Likewise, the name of his wife was changed from Saria to Sarah.

The scriptures also talk about a major name change in the story of Jacob whose name was changed from Jacob to Israel when God began to craft the creation of the nation of Israel thousands of years before the creation.

When the Almighty God decided to use an infamous prosecutor of the Christians in the name of Saul, God Almighty changed his name from Saul to Paul because this name had the spiritual vibration necessary to convert him into one of the most formidable instruments in spreading the gospel to the early Christians. God brought divine blindness upon Saul on his way to Damascus to prosecute the Christians. But when Saul later regained his sight by divine healing, he was transformed into one of the greatest Christian leaders of the early church.

The story of Jabesh also found in the scriptures is an important example that illustrates the importance of name change.

When Jabesh was born, there was a great famine, so his parents felt it was wise to give a name that reflected that famine upon the new born baby. The scripture records tell us that this name Jabesh and what it signified kept following 'Jabesh' as he grew into a man because all Jabesh experienced was one calamity after the other until he discarded the name.

So we were a free independent nation by 1960, but still wearing the old name or garment of NIGERIA which was a name or instrument of colonial bondage. There is simply no level of corruption and exploitation that compares to the kind of exploitation and CORRUPTION in caps NIGERIA experienced at the hands of our Colonial Masters and to retain that name was a grave error of history. Its not yet late to have a dramatic change of name, because the reasons are not only scriptural, but commonsensical and the issue of name change is treated in more detail in proceeding chapters.

Our Colonial Masters worked in collaboration with our local Chiefs and leaders to exploit NIGERIA by carting away, by the shiploads, our precious resources, such as palm oil, animal hides, gold and silver and a host of other natural resources and at little or no cost to our colonial Masters, who then returned finished products like soap, gin, guns to kill ourselves etc at very exorbitant prices, considering the fact that our local Chiefs and Paramount Chiefs simply handed over to our colonial Masters vast acres of fertile land to cultivate our natural resources at little or no cost and the worst thing was that these plantations were cultivated and harvested by exploitative human labour equipped with no industrial machines like tractors, but their bare hands.

The British Empire built most of the tracks of her intricately networked London underground tube (train) stations with black labour, using their bare hands to dig and carve the intricate underground network of tunnels buried under the city of London. Yes it was slave labour of Africans that built the London Underground train network and this is the current




diagram of the London Underground. The London underground train network popularly known as the Tube may very well be one of the great wonders of the world.

Not only did slave Labor build the London Underground, but also the money that financed these gigantic projects was funded by the foreign exchange generated via the selling of finished products made from the natural resources stolen from our lands. Now let's be honest, this is as bad as exploitation can ever get and was the foundation of how the seeds of corruption was sown by our Colonial Masters in collusion with our Paramount Chiefs and elders who were too happy to receive simple gifts like cigarettes, textile, gin, soaps and detergents and even guns we were meant to use to kill and suppress ourselves. What were the guns meant for if it was not to arm our Paramount Chiefs to use against the very people they were meant to protect.

This is just a small aspect of the gigantic levels of CORRUPTION and exploitation NIGERIA suffered at the hands of our Colonial Masters and our local Paramount Chiefs.

When NIGERIA regained her independence in 1960, even though our post colonial leaders like Nnamdi Azikiwe were not as corrupt as what we are experiencing today, yet they were not Angels by any stretch of the imagination. Nnamdi Azikiwe was the founder of the University of Nsukka (UNN) and his massive hostel project known as The Nnamdi Azikiwe hostels was constructed while he was still in power and still bears his name till today. Can we begin to imagine if Thomas Jefferson, one the founding fathers of the USA, built a University of America in those days and then personally build a vast real estate business while serving as founding father? Well, that is exactly what Nnamdi Azikiwe did with no questions asked.

When our colonial Masters were done stealing from our lands our new found leaders continued from where the British Empire stopped and the Spirit of corruption installed by our colonial Masters kept growing until NIGERIA economy COLLAPSED under the Presidency of Buhari.

Therefore to blame only President Buhari is in error, because CORRUPTION in Nigeria started in 1914 after the Amalgamation of North and South Protectorates which is exactly 108 years ago, so I can confidently claim CORRUPTION in Nigeria is at least 108 years old.

NIGERIA is like a patient suffering from malaria, hypertension, chronic diabetes, heart, liver and kidney failures and brain and colon cancer, all chewing and ravaging a human body simultaneously. This is an excellent imagery of how sick NIGERIA is today in the waning days of the Buhari led administration.

Concerning the emergence of the Obidience/Obidient Movement, this movement arose out of the current vibrations in Nigeria. These are vibrations that border on a revolution. As at 2010, Egypt was anything but a badly run nation under the leadership of Late President Mubarak. Mubarak was infamous for being one of the most vicious dictators in human history, having ruled Egypt for more than 30 years.

And even after over 30 years of being in power, the Mubarak led administrations could not deliver steady electric power supply, but the new President, Asisi delivered to the people of Egypt solid uninterrupted power supply in under ten years of being in power.

No wonder Peter Obi ascended to Egypt to see for himself, how Egypt did it so he can apply the same formula in Nigeria.

What were the factors that triggered the Arab Revolution?

The factors that triggered the Arab Revolution are very much akin to the factors that have inspired the Obedient movement. CORRUPTION AND BAD GOVERNANCE is the culprit.

All Arab Nations in North Africa form the bulk of Nations that experienced the revolution.

North African Nations were by the end of the first decade of this century

(2010) saddled with high rates of poverty and general deprivation. The people were weeping and in economic, political and social anguish just as is apparent in Nigeria today, 2022.

The Arab Spring started on the 11th of March 2011 and ended on the 24th December 2012 and it was a single act of defiance from a street vendor that triggered the ignition of the Arab Spring.

Arab Spring was a series of pro-democracy uprisings that enveloped several largely Muslim countries, including Tunisia, Morocco, Syria, Libya, Egypt and Bahrain. The events in these nations generally began in the spring of 2011, which led to the name. However, the political and social impact of these popular uprisings remains significant today, years after many of them ended.

## What Is the Arab Spring?

The Arab Spring was a loosely related group of protests that ultimately resulted in regime changes in countries such as

Tunisia, Egypt and Libya. Not all of the movements, however, could be deemed successful - at least if the end goal was increased democracy and cultural freedom.

In fact, for many countries enveloped by the revolts of the Arab Spring, the period since has been hallmarked by increased instability and oppression.

Given the significant impact of the Arab Spring throughout northern Africa and the Middle East, it's easy to forget the series of large-scale political and social movements arguably began with a single act of defiance.

The Arab Spring began in December 2010 when Tunisian street vendor Mohammed Bouazizi set himself on fire to protest the arbitrary seizing of his vegetable stand by police over failure to obtain a permit.

On the other side of the Sahara Desert, NIGERIA is going through the infancy stages of a revolution. THE OBEDIENT MOVEMENT.

When the Buhari led administration took the mantle of power, NIGERIA was not in very good shape, so the Buhari Campaign strategists came up with "NIGERIA for Change" slogan. NIGERIA did change quite alright, but changed in all the wrong" ways. Not one single sector of the economy was spared as galloping inflation seized NIGERIA, choking her with fists of steel and making epic nonsense of the Giant of Africa. Inflation seemed to be running like a mad man, coupled with what the Nigerian people were facing with essential services such as International Passport issue or renewal and even National Identification Number (NIN) service. Most public services were monetized. For instance, after paying the set fees for a passport, the next thing one will hear is "bring 15 k for slot". So I asked, what on earth is slot? Sounds like the name of a very sluggish animal .So what has sluggish got to do with speed. Slot is simply another strain of corruption. (This was a personal experience).

And they said there is a serious backlog, so if I wanted my passport to be issued on time, I needed to pay an additional 15K for express service. I refused to pay, telling them I will wait it out, so after applying for a renewal in December 2021, I got my passport in July of 2022, seven months later.

Therefore, it is these kinds of atmosphere coupled with runaway inflation that is running like a madman that gave wings to the Obidient Movement and what great wings the movement has, flapping with all her might and gaining incredible altitude by the day to take NIGERIA back.

Nobody needs to see the writing on the wall to know that NIGERIA is rife for a revolution and often times Nature begins to prepare even from birth an anointed person to lead the revolution and perform the cleansing.

In the late 1800s Herbert Macaulay was a significant personality during the colonial era and even though he was a Nigerian surveyor, very well known in the land and property business, his career was riddled with stains of corruption and this goes to tell us that as the British Empire was exploiting Nigeria natural and human resources, instead of prominent Nigerian personalities such as Sir Herbert Macaulay, decide to help cure corruption, he became a part of it and the proceeding story tells of Nigerians Herbert Macaulay was a notable personality during the Colonial era and even as early as the 1800s, he as a NIGERIAN was accused of multiple cases of grand CORRUPTION, so it seems that instead of prominent Nigerians to help weed out the corrupt practices of the British Empire, they colluded and joined in robbing fellow Nigerians of their resources. And the proceeding story is historical evidence to these facts.

Upon his return to Lagos in September 1893, Herbert Macaulay resumed work with the colonial service as a surveyor of Crown Lands.

He left the service as land inspector in September 1898 due to a growing distaste for the British rule of the Lagos Colony and the position of Yoruba land and the Niger Coast Protectorate as British protectorates.

Authors such as Patrick Dele-Cole have noted the abuse of office, , allegations (levelled by his British superiors) and pursuit of private gain controversy that clouded Macaulay's resignation as surveyor of Crown Lands, citing British Colonial Government dispatches, notes that Macaulay behaved dishonestly, by using his position as Surveyor of Crown Lands to help friends , acquire crown grants and persecute enemies by granting their lands to others".

She further writes that Macaulay "obtained crown grants under false names and then sold them at a profit"(familiar?).

In October 1898, he obtained a license to practice as a surveyor. As a surveyor, his plans and valuations included E. J. Alex Taylor's house on

Victoria Street, Henry Carr's residence at Tinubu and Akinola Maja's house and Doherty Villa at Campos Square.

So it is evident that even Nigerians where involved in corruption as early as the late1800s.

After the Amalgamation of Nigeria in 1914 by the very firstGovernor General of NIGERIA, there followed a string of other Governor Generals that governed Nigeria, I mean plundered Nigeria, right up to 1960 when NIGERIA regained her independence, then our new found leaders continued from where the British Empire stopped. Albeit not to the levels prevalent today. This is the full list of Governor Generals of NIGERIA since1914

This in a nutshell is the history of how the seeds of corruption was sown 108 years ago by our Colonial Masters, The British Empire.

# ANALYSIS OF COLONIAL ERA CORRUPTION AND EXPLOITATION IN NIGERIA (1914 to 1960)

It is no longer news that our Colonial Masters harvested our natural and human resources to levels of Biblical proportions. It is therefore pertinent at this point in the history of NIGERIA, when this issue of CORRUPTION has literally brought NIGERIA to her knees, that the issue be given more attention by historians, so NIGERIANS young and old can see for themselves how we got to this level of CORRUPTION and bad Governance that brought Nigeria to her knees. CORRUPTION in Nigeria had it's origin many decades ago and possibly centuries before the end of the 1800s. This means that CORRUPTION started several decades before the amalgamation of NIGERIA in 1914 by the very first Governor General (President) Sir Lord Laggard.

What happened in 1914 when NIGERIA was created was a high level fine tuning of the instruments of exploitation for a more effective way of stealing our resources; resources so important to the survival and prosperity of The British Empire.

Having successfully dissolved our age old Pattern of selecting Chiefs or Kings, and having successfully installed the PARAMOUNT Chiefs, the train of exploitation was set to start moving.

There were two distinct arms of the instruments of exploitation that our Colonial Masters put in place for speed, efficiency and high volume exploitation. The first arm handled produce production, harvesting and export to Great Britain.

#### How was this achieved?

First our Colonial Masters dissolved all traditional rulers mandate that was a structure in place in Nigeria for thousands of years. The only traditional rulers that were retained were just a few who danced to the tune of our Colonial Masters.

Our Colonial Masters then after kicking out our age old traditional rulers, then went ahead to create what was known as PARAMOUNT Chiefs. Even the choice of the word Paramount Chief is most suggestive of dominance to the set pattern of selecting Kings in Nigeria.

The PARAMOUNT Chiefs were tasked with the duty of organizing cheap labourers to plant and harvest our variety of produce such as palm oil, groundnuts, cotton, corn, soya beans and a wide variety of other produce.

There was also great activity of exploitation in the area of minerals such as gold, silver, iron ore and a host of other minerals.

The job of the Paramount Chiefs was to harness and organize the local farmers and laborers, having furnished them with vast acres of fertile land and some simple tools used in plundering the soils of Nigeria and then carting away our precious resources by the shiploads to England. In return for their work of organizing the local farmers and labourers, the Colonial Masters had a steady supply of finished products manufactured from stolen resources to the homes and sometimes Palaces of the Paramount Chiefs. Paramount Chiefs that did not meet up with expected harvests or quota were punished with finished products sanctions and those that met up were celebrated with extra supplies and even Knighthood of the British Empire. So, sanctions as we know today did not start today and this has become a favourite weapon of The United States of America.

In the Eastern regions of NIGERIA a special form of Paramount Chiefs evolved into the indirect system of governance, because the Igboman could not just swallow direct instructions from the Whiteman and resisted vehemently. So our Colonia Masters came up with the indirect system of Governance or indirect system of EXPLOITATION.

In this system of indirect rule, our Igbo Chiefs and Kings were given autonomy to rule their people but with our colonial Masters breathing down their necks. Therefore, exploitation of the Eastern regions was less severe which accounts for the great levels of development apparent in the eastern regions as early as the turn of the 1900s when compared to other regions especially the northern regions.

Groundnut pyramids comparable to the stone pyramids of Giza in Egypt, sprung up in many northern cities especially Kano. Palm Oil flowed from our palm trees in the Eastern regions. Cocoa plantations sprung up in many Western villages and towns. Cotton from the northern regions was a very precious commodity that kept our colonial Masters people warm with 100 percent cotton clothing and blankets.

For centuries this was the structure in place and as NIGERIA was being plundered and exploited and getting poorer and poorer by the minute, our Colonial Masters were building castles , developing and evolving into industrialized Nations and all this stealing from our fertile soils was the bedrock upon which the industrial revolution of the 1900s took root. But today all the glory of being World Super Powers goes only to the people who used our backs to climb to the status of Super Power, while we are referred to as Dark Continent, Third World (while they labeled themselves First Word) or the more common coinage, Developing Nation or Emerging Economies . Let me stress, all these names were names the Whiteman gave us.

As the exploitation got more organized, our Colonial Masters began building a vast network of train tracks, seaports, where giant oceangoing ships could dock and roadways from the hinterland that made moving high volume produce very easy. Not only were millions of British pounds spent on cargo trains but the fast emerging middle class could travel by train, in style, to many destinations, but most importantly the first class train cabins were inspired by the need to make our oppressors more comfortable as they travelled and crisscrossed

NIGERIA in search of Paramount Chiefs who danced to their tunes because let's call a spade a spade. The extremely high levels of exploitation would not have been possible without the cooperation of British Empire Paramount Chiefs. This really makes Judas betrayal of Jesus like child's play. By the time NIGERIA was amalgamated in 1914, this structure was already firmly in place and getting more intricate and sophisticated by the minute.

So to further enhance exploitation of NIGERIA the nation of NIGERIA was created and as mentioned earlier, Sir Lord Lugard was the first Governor General (President) of NIGERIA and served at the instance of the King of The British Empire, King George V So let the records be made clear. The Whiteman did not create the nation of NIGERIA because they loved our faces, but it was just to make exploitation much more efficient and easy. Therefore, the name Nigerian should have been dropped speedily like a hot potato the minute Nigeria regained her independence in 1960.

After the tenure of Lord Lugard that spanned from 1914 to1919, the King of England appointed the second Governor General Sir Hugh Clifford (1919-1941) and one Governor General came and left one after the other, until 1960 when NIGERIA regained her independence.

When NIGERIA regained her independence in 1960 under the leadership of Nnamdi Azikiwe, the structures of exploitation was at a very high level and while it was true that much changes of Biblical proportions occurred in Nigeria in 1960, the fact remains that the seeds of CORRUPTION sowed by the British Empire was already enthroned in the hearts of the average Nigerian and what happened in Nigeria under the Buhari led administration in 2022 that witnessed the total economic collapse of the Giant of Africa was inevitable.

The second arm of instrument deployed for effective exploitation started when our produce arrived into British Ports. Factories inspired by the industrial revolution were all waiting with greedy throats to receive our produce which was then transformed into thousands of very attractive products that make life sweet and thereafter, the products were exported back to Nigeria for sale at exorbitant prices. Of course the Paramount Chiefs had truckloads of gifts delivered to their homes and Palaces to keep the oils of exploitation flowing.

Such was the massive scales of CORRUPTION meted to the people of NIGERIA from our colonial Masters that spanned several centuries as far back as the 16 and 1700s.

This article will be incomplete without talking about our post Colonial leaders, Nnamdi Azikiwe and a couple other personalities and how they received the baton of power from our colonial Masters and how they ran with that baton.

Let the truth be told though the heavens fall, because our post Colonial Leaders were not Angels by any stretch of the imagination. Although levels of CORRUPTION concerning our post Colonial leaders could be said to be only an ant hill in comparison to the levels we see today, yet what NIGERIA CORRUPTION evolved into by the closing days of the Buhari led administration can be classified as a mountain of CORRUPTION As evidence, there was some levels of CORRUPTION within the ranks of our post colonial leadership, it looks odd in a way that the first top NIGERIAN University, The University of Nsukka had a top politician, Dr. Nnamdi Azikiwe owning vast real estate properties within the University of Nsukka known as Nnamdi Azikiwe Hostels. This is not to fully imply that these hostels were constructed with stolen State money, yet it was quite inappropriate for Dr Nnamdi Azikiwe to become a major investor in the development of the first Prime University in Nigeria when he was still in power.

As Dr Nnamdi Azikiwe was acquiring vast real estate properties, so were other politicians and this was done in the full glare of the public. With little or no questions asked.

Can we begin to imagine how distasteful this would have been if a personality like Jefferson, one of the major founding fathers of the United States of America, got heavily involved in owning properties in the very first State University in America? This would have been outrageous and the American people would have cried foul. But Nigerians can never complain, but that is changing rapidly as Nigeria witnessed total economic collapse at the waning days of the Buhari Administration.

This in essence was the level of CORRUPTION apparent in Nigeria before the NIGERIA BIAFRA war broke in 1966 and transformed to a full blown war by 1967.

From 1966 to 1970 everything stood still as the war raged, consuming human lives and resources by the minute and I don't believe anybody was interested in amassing great wealth within this period, but when the war ended in 1970, CORRUPTION started again from where our post Colonial Leaders left it.

Nigerians who were of age in 1975 to 1980 will recall a time when cable telecommunication became a major Federal Government project and the entire Nation had thousands of miles of roads dug up to lay the cables that will power the huge project. It was famously known as the ITT project and even though millions of naira was spent digging up NIGERIA, the project was never completed, because it was abandoned, thereby inspiring Fela, Anikulapo Kuti, King of Afro Beat music to release a hit single ITT, now rephrased to International Theif! Theif!! (ITT).

CORRUPTION even reared its ugly head within the academic system of which I was personally impacted when in 1976 the first major WAEC examination question leakage occurred known as expo 76. I can personally confirm that I saw all WAEC questions for the 1976 academic year with the exception of Chemistry.

We were pleasantly horrified at the level of examination question leakage that NIGERIA experienced. I mean, I personally saw and benefited from this mass leakage,so accurately delivered with dotted Is and crossed Ts. However, in those days we did not spend a penny buying these WAEC QUESTIONS, the questions just kept oozing out daily from mystery sources and we just kept our focus on the constant flow of questions than reading our books, a recipe for brain damage. But it baffled we students, what was the purpose of this evil strain of CORRUPTION if it was not inspired by human beings amassing great wealth they can never consume in ten life times.

Or it could be that huge sums of money at a higher level of the academic command chain had exchanged hands and was not visible, but the fact remains that money must have exchanged hands somewhere along the chain of command in the WAEC hierarchy.

Needless to say the students were the ultimate victims as WAEC cancelled WAEC results of an entire nation and almost all fellow students in my class of 76 had to retake WAEC. A special class called SR or 5 repeaters was created in almost all Secondary schools.

However, what is so baffling is that even today, WAEC questions leak every year and with the aid of information technology this evil has transformed into a multi billion naira business, because 7 out of every 10 WAEC candidates attest to seeing and buying examination questions at the rate of 1,000 naira per subject or in some cases, I have heard figures as low as 400 naira per course. The principal drivers of this process are the thousands of invigilator paid with tax payers money to invigilate examination questions and answers and operating expo website.

As evidence, just search the internet for NAIJA WAEC Expo or Expo WAEC and you will see a host of sites destroying the brains of our children and the Federal Ministry of Education just folds her arms and watches as CORRUPTION consumes the brains of our children.

Having discussed what I firmly believe is the origins of corruption in Nigeria, I will like to share with my audience my personal experience with CORRUPTION in Nigeria and in this segment, I will share just one little aspect of corruption in two separate projects with the Ministry of Education and a foremost Academic Institution and I will refer to this academic institution in these words, to protect the identity of the academic institution as my relationship with the institution is still active. Therefore, corruption rears its ugly head in a multitude of dimensions. Under declaration of crude oil production and exports is indeed the mother of all grades and colors of CORRUPTION. Over inflated contracts and projects is yet another color or form of CORRUPTION. Fake or ghost contracts or projects is yet another color of CORRUPTION. Disappearing pension funds is yet another form of corruption and the list is long. Therefore, in essence, CORRUPTION can be perpetrated in hundreds of ways or tactics. Having said so much, I will now share two separate colors or tactics of CORRUPTION I personally experienced in 1997 and 2016 to 2022 respectfully.

### CHAPTER 2 MY FIRST PERSONAL EXPERIENCE WITH CORRUPTION IN NIGERIA AND HOW CORRUPTION IS DESTROYING NIGERIA

In 1997, I commissioned a movie Production Studio in Lagos called Visions Questron Productions.

It took me three years of piling up equipment and soft ware to run the studio and when I commisioned the studio in 1997, my first major Production project was to produce 100 hours of video lectures in six core secondary school courses namely English, mathematics, chemistry, physics biology and introduction to computer programming.

Most secondary schools had ill equipped laboratories for all science courses, so I figured the Video Tutor lectures teaching a host of laboratory experiments including animal and plant dissections would greatly assist students in excelling in their exams, because each school had a limit to the number of rats or rabbits they can catch to teach animal and plant dissections and experiments . This form of virtual learning was developed a whopping 25 years ago before Corona Virus suddenly made Virtual learning an essential product.

Unfortunately, the Federal Ministry of Education Abuja did not share the same sentiments as I did 25 years ago and this is how it happened in a nutshell. I applied to the Federal Ministry of Education Abuja to supply my Video Lectures to all 71 Federal Secondary schools. This was in 1997.

The Ministry seemed very excited at my proposal, because nobody in Nigeria had ever mass produced video lectures to the level I did in 1997. So, I was also excited that at last my money and sweat that went into the production of the Video Tutor was not a wasted effort.

A Video Tutor 15 man review committee was quickly set up by theFederal Ministry of Education Abuja to review the Video Tutor Programs and make recommendation to the Hon Minister of Education .The committee had as its Chairman Hon Dr (name withheld) with Mr. (name withheld) as secretary.Subsequently, I was invited to make a detailed demonstration of the Video Tutor learning aids so when I arrived for the demonstration, I was invited into a fairly large hall where all members of the 15 man committee were seated with Dr Tura seated on the Chairman's chair.

My aids and I quickly set up our equipment for the demonstration and soon the demonstration was in progress. The committee made some comments and requested few adjustments to the video programs so asked me to effect the adjustments and return for a second screening. I returned to Lagos and my excitement was palpable.

I returned to Lagos and my excitement was palpable. I rehired 6 teachers for all 6 courses and soon the recording was complete at the famous Igboebi College Yaba Science Laboratory and I was ready to return to the Ministry of Education Abuja with the fully adjusted video lectures. The committee congratulated me for a job well done and it was at that time the Committee agreed that the Federal Ministry of Education will purchase all video lectures for supply to all 71 Federal Secondary schools under her direct care and supervision.

I therefore submitted my application for the supply of all my video lectures at a cost of 129 million naira and the Federal Ministry of Education were my clients. I can't tell you how over the moon I was with excitement.

I did not know I could get paid for the demonstrations I made, so I was requested to submit an invoice for three demonstrations at the rate of 5 million per demonstration giving a total of 15 million naira. How on earth can one justify paying five million naira for just one simple video demonstration that lasted one or two hours? This is another strain of corruption.

It took me about two years of PR work with the ministry of education after the Video Tutor screening before there was a green light that soon the budget for that year would be out with high hopes that soon I will be paid to supply all 71 Federal Secondary schools with the Video Tutor learning aids.

#### LIES! LIES!! LIES!!!

I was so foolish I should have read the writing on the wall because a red flag should have alerted me, I was just wasting my time with the Ministry of Education because if they could not pay me 15 million for the Video Tutor demonstrations, why on earth did I think I will ever smell a penny of the 129 million naira that was the quote I submitted to supply all 71 Federal secondary schools. Just to point out, some members of the committee advised me to quote for my demonstrations at the rate of 5 million naira per demonstration with a gentleman's promise or pledge to return 10 million naira out of the 15 million naira invoice while I retained 5 million naira. I agreed and subsequently issued an invoice for15 million naira.

Well you can never believe what happened. After I submitted the bill for 15 million naira, that was the last time I ever heard of my 15 million naira invoice. I did not get a penny from that invoice. They had no pity on me and at the time, I did not notice I was short changed, because the excitement of the 129 million naira supply clouded my vision.

At the end of a three year production and public relations campaign, Mr. (name withheld) informed me in his office that the application to supply Video Tutor learning aids to all Federal Secondary schools was rejected by whom they never told me.

When he passed this gloomy information to me my heart sank, as depression seized me immediately. My hands got cold and moist. After a minute or two of weeping internally, I raised my head and asked, how about the invoice of 15 million naira for my three demonstrations and at that point Mr. (name withheld) violently stood up from his chair and ordered me to leave his office immediately and I complied with no further questions, because I knew the next thing that could happen was security will be called to throw me out.

Such was the inglorious end to a video tutor project that took me a whopping one year to complete burning one hundred liters of diesel per week for at least 8 months trying to make a product that will help in no small measure uplifting the standards of education in Nigeria.

I went home and wept for days without end for the great value of time and money and teachers that poured their knowledge out in the videos, that it all ended in tragedy, leaving my studio and equipment totally drained and exhausted from over three years of producing and nurturing an academic learning aid that CORRUPTION stole. It was never clear to me how on earth anybody in their right mind would reject an innovative learning aid that will greatly assist our students. The truth is that this money was redirected to some private account and shared and our children robbed of an important learning aid that would have greatly assisted their studies, a product that Corona Virus suddenly turned into an essential product in any academic system 25 years later.

However, since I have no evidence or document to prove that the law makers in the house deleted the budget for prime learning aid supply to 71 Federal Secondary schools at that time, even if it is true that the lawmakers deleted the budget for learning aids, the question is why such a senseless decision to help improve academic standards in Nigeria because 25 years after, Corona Virus has shown us the great importance of virtual learning.

Since the reasons why the Federal Ministry of Education rejected such an innovative learning aid were most unclear, there could be other reasons that are even more dire.

The inability of government to absorb and digest innovation, creativity, inventions and academic postulations being churned out by the Nigerian people.

Government must be up to speed with the creative process of her people in whatever discipline. Video Tutor learning aids in 1997 was a new and innovative idea but Government seemed to lack the eyes that saw what the producer of Video Tutor saw.

My elder brother is a prominent Maritime and human rights lawyer and when he submitted a project to re-engineer some aspects of cabotage law concerning how cargo ships conduct their business of conveying goods to and from Nigerian ports and after showing government detailed facts how 19 billion naira could be generated by ports authorities, government just can't seem to get the point. So 19 billion naira is just sitting in limbo.

Can we begin to imagine the number of innovative ideas that are sitting in limbo and gathering dust in the office desks of millions of Nigerians?

I therefore will recommend to the incoming administration no matter who is the victor to encourage the submission of academic postulations and theories to enhance and accelerate efficient and effective nation building. A site like this and with effective sensitization will give the general public and academic community an avenue to share their innovative ideas of all kinds.

Nigeria is suffering from the most potent brain drain ever experienced in Nigeria history. This is also part of the same problem. The Inability of government to create adequate space for the labour market so look around and ask questions. You will see graduates selling petrol in petrol stations. Graduates of all disciplines are working as POS sales boys and girls Graduates are operating tricycles and motorbikes and doing all kinds of jobs simply not befitting of their qualifications.

And these are for Nigerians who could not travel or escape abroad to Nations that had greener pastures. Nigerian brains; the best and the brightest of our young labour force are in distant countries that could contain and receive their academic or vocational training and put them to good value in developing their respective nations, so while the cream of our labour force is helping build and develop distant countries, Nigeria is suffering from an anaemic work force because Nigeria is suffering a massive haemorrhage of brain power. In Canada, it is reported that Canadian government has employed 633 Nigeria trained medical doctor's since 2020. In the UK in 2022, it was reported that over 300 Nigerians were certified and employed as doctors in 2022 alone and the statistics of massive brain drain cuts across almost all professions and Nations on the face of the Earth including Greenland and far away Australia, our skilled and talented work force have anchored themselves, abandoning the ship called Nigeria with no captain or crew to drive the ship. Nigeria is fast becoming a crew-less ship. Ship without a captain or crew is a very dangerous ship to sail in, so Nigerians are busy leaving the country in droves for better sailing ships.

## CHAPTER 3 NNAMDI KANU AND THE FAILURES AND CONSEQUENCES OF BANNING HISTORY STUDIES IN SCHOOLS

I am not a politician, but a only historian and part of what we do is to document and record history, the good, the bad and the ugly, and indeed speaking truth to power. That is what we are trying to do and that is what I have done in this publication, "The stabbing of Nigeria- decay of the academic system.

I am not in support of any movement either for or against any form of the creation of new nation, however, it is pertinent to point out factors that may have militated in the raise of these movements.

The bottom line of this discourse is that Nigerian do not want another bloody war as was previously experienced in 1967. Whatever the differences, these issues most be resolved without a single recourse to any forms of violence of any kind.

In 1970, at the end of the war, the Yakubu Gowon led administration felt that to help foster peace and harmony and to help forget the horrors of the brutal war that took over two million lives, all history studies shedding light on the dynamics of the brutal war had to be banned from all school curriculum from secondary school to tertiary education. Well that is as bad a policy as any terribly flawed policy can ever be, because what we have so far experienced is the direct opposite of what was intended. Banning history studies in all Nigerian schools was not only scientifically incorrect as a vehicle to forget the horrors of war, but the vacuum created by lack of knowledge of the dynamics of the war, may have contributed to the dynamics we see today involving Nnamdi Kanu and his movement, because that vacuum had to be filled up by the youths. And when there is no Federal Government guidance, then any sentiment can take root and fill the vacuum.

It took a staggering 46: years after the war ended in 1970 for the ban on history studies to be reversed. That is almost half a century and too long a time to be wallowing in a flawed academic policy.

In 2016 the Executive Secretary of the Nigeria Education Research and Development Council (NERDC) Prof. Samalia Janaidu explained why History studies were reintroduced into the basic education level.

The decision, according to him "became imperative due to current happenings in Nigeria, which tend to justify the belief that Nigerians especially youths have lost their sense of value and origin, recognizing not the sacrifices made by their forefathers for the peace and unity of Nigeria.

He further said majority of our youths have gone astray. They have lost the Spirit of patriotism and sacrifice due to lack basic knowledge of their roots and origin."

According to the Prof Samaila, "there is no doubt that our children are lacking in the knowledge of our history and that has resulted in lost values for ourselves. It has also had a terrible effect on our National life."

"But we are very optimistic that the rich content of the new History studies will correct all anomalies, thereby reshaping the thoughts of our youths and instilling the spirit of patriotism and sacrifice in them" end of quote.

So there you have it. The academic Policy blunder of the Yakubu Gowan led administration in 1970 that took a whopping 46 years to correct, is certainly one of the culprits of the current state of security and secessionist tendencies apparent in Nigeria today so the authorities must take the blame and not the youths and do everything possible to contain and control the situation in most diplomatic dialogue.

My novel Terrors of War is a childhood story of the Nigeria Biafra war. Amazon.com described the novel as "a harrowing hope filled memoir and at times a wise and important fable of the Nigeria Biafra war seen through the eyes of a little boy, but revealed through the heart of a man". The novel therefore, is not a political or military novel, but just the wartime experience of a little boy and The United Nations (UNESCO) that wrote the foreword for the 400 page novel said, and quote- "the book promotes peace, tolerance and dialogue. These are principles that are at the heart of the United Nations mandate to UNESCO whose activities isto promote a culture of peace in the world"

So after all these rave reviews from global institutions and even Pope Francis issued a well worded prayer over the novel in a letter to the author in 2016, how come the NIGERIA academic system has not noticed the novel. One word CORRUPTION" because I did all in my power to push the novel into the academic system but the cost of conducting PR in Nigeria is often times overwhelming and often times great projects and ideas are dropped out of frustration. That was my experience with Terrors of War.

But right now as we approach the 2023 elections and with the Nnamdi Kanu movement still in the picture, it is time for Government to step in and make history studies effective with literature that foster peace, reconciliation, tolerance, forgiveness and brotherhood. It's not late to begin to repair the damage banning history studies in 1970 may have caused when novels like **Terrors of War** and many other history books were banned.

A news paper report on a radio show in Abuja in 2016 where Prof Samaila Junaidu expressed NERDC position on lifting the ban on History studies is published in this chapter.

The Yakubu Gowan led administration committed a blunder of epic proportions that baffled social scientists and conflict resolution experts around the world, because it defied any atom of logic what informed their thinking in 1970 that suggested that hiding or banning history studies in Nigeria was anything but an untested theory, contrary to a well known theory that suggests hiding and pretending that a war never took place has the ability to create the kind of youth movements we see today. This kind of ignoring of a major holocaust in Nigeria is an unseen force being fostered. it's some kind of complex psychology that begins to breed resentment and discontent especially as at this time in the history of Nigeria', it seems it's the turn of the Igbo man to produce a President, but something always seems to pop up and derail the plan.

But not anymore as the Obidient movement is not made of man. This singular event of having the first Igbo President since Nnamdi Azikiwe will serve as pouring ice cold water on the Nnamdi Kanu issue and all will be well .So many divergent vibrations in Nigeria will begin to vibrate in unison. And the matter will be settled for ever.

Give to Caesar what is Caesars'. Do not withhold it when it is in your power to give. So while correction has been taken to deban History studies in Nigeria, this correction must also be reflected in decisive actions to repair the damage done by the Yakubu Gowan led administration.

Reconciliation is not a thing done ' by force" The spirit of reconciliation and peace are one and the same and you can never force peace. Peaceand reconciliation are nurtured. It takes time, but it is this same time that is needed to experience healing. We have all heard the proverb" time heals". That is very true. Time really heals given the appropriate atmosphere and soil.

Banning history studies in Nigeria was like removing the manure from the academic soils of Nigeria' and replacing it with saw dust. And when you apply saw dust to a corn farm, Instead of manure, just wait a few weeks for the corn to be ready for harvest. What the farmer will harvest is corn ears that look like corn ears until you peel the corn ear. All you will see are corn cubs with a sprinkling of corn seeds. Kwashiorkor corn; that's what the farmer will get plus the corn may not be resistant to diseases; the corn may be suffering from a number of diseases. I am speaking in a parable.

It is a fact that the Igbo man has not been given the opportunity to pilot the ship called Nigeria', in a full democracy since Nnamdi Azikiwe, apart from a short six months' tenure as Military Head of State in 1966 when Agui Ironsi toppled the Nnamdi Azikiwe led government for alleged corruption in January 1966. Ironsi was in turn toppled by the Gowan led coup in the counter coup only six months after he toppled the Nnamdi Azikiwe led administration.

The war ended in 1970,50 whooping years ago and up till this time the only time in the history of Nigeria' that came close to fulfilling a fair quota in all Geo political regions in power rotation was when Goodluck Jonathan became President but he was just a President by default. An Accidental President who ascended the throne of Nigeria' at the passing of Yaradua. And in any way, he is not an Igbo man.

Not to allow an Igbo man the Presidency is an indication that some of the wounds of war are yet to heal and if some of the wounds of war are yet to heal, 50 years after the war ended, then that is the by product of banning history studies in Nigeria.

This ban simply snuffed off the oxygen in the NIGERIA academic space that could foster peace and reconciliation and poisoned the NIGERIA soils with saw dust instead of manure.

And finally in conclusion I must say, I did everything in my power to introduce my peace novel into the academic system of Nigeria' but all I ever heard is "do you have any links to the President or Minister for Education? So it's all about politics and who-knows-who? Why must Nigerian projects; I mean high quality projects such as the ones I handled be subject to knowing the President or Minister for Education. In spite of all the credentials I submitted, including letters of endorsement from UNESCO or even The Vatican, Pope Francis amongst other endorsements, be ignored and favour given to only people, often times politicians, who bring notes from the President or some Senator or Governor. Why do we play politics with the soul of NIGERIA?

Then we wonder why Nigeria Economy COLLAPSED!

Can we begin to imagine how many great ideas and projects are swept under the carpet just because you do not have a note from the Presidentor Sanator? They are in hundreds of thousands if not millions.

In democracies, in democracies with bad governance, the best and brightest brains sink to the bottom of the river, while the crooked, dull and incompetent float to the top while in democracies with good governance, the best and brightest brains float to the top, while the dull, crooked and incompetent float to the bottom of the river. This is exactly what is happening in NIGERIA for decades. Detention of Nnamdi Kanu is not the solution. It simply masks the problem by suppression of the people. Simple physics tells us that when something is suppressed, there will be an equivalent expression or explosion to the suppression the minute there is the smallest gap to express the suppression. That gap may take a while to form, but it's just a matter of time and it will surely form. It is actually forming day by day.

How can a father of 6 children begin to blame his children for not attending school and becoming doctors or professors when he failed to provide the funds because it is the duty of the father to provide the funding and atmosphere for the children to be nurtured properly. There is never any money for school fees yet he drives fancy SUVs and eats and drinks the best foods and wines like a glutton while the children watch. Yet there is no money for school fees?. It's just a matter of time and there is bound to be a revolution. Something one day will trigger it. It's happened time and time again from the revolution against apartheid of South Africa to the Arab Spring/revolution in North Africa, these kinds of events breeds a larger event; a revolution. That is the state of Nigeria today,

The Igbo man is very bitter about gross marginalization meted to her people for decades without end. And when the Buhari led administration took the mantle of power; let me put it in very simple words. This is the most corrupt, incompetent, reckless, greedy and brazen administration ever to hold the mantle of leadership and simply does not have the oil of leadership. All they have is the mantle of leadership and when one holds a mantle of any kind without the corresponding oil to power the engines of leadership, then you arrive at Nigeria' in 2022. A failed state.

When a state fails, it loses the moral authority to govern and police her people effectively, so the government resorts to throwing her citizens in prison. It's happened time and time again and today Nigeria' is experiencing the same thing by incarceration of her people, applying all tactics to attain her goal. And just to note, it is not only when a person is locked up in prison that incarceration has occurred.

## DMO raises alarm over cost of debt servicing

STATISTICS obtained from the Debt Management Office (DMO), in Abuja, have reveals that external debts have cost the country a total of \$1.62billion in interest payment in the last five years.

This is coming at a time when The Federal Government spent a total of \$331,059, 850 on servicing its external debts in 2015.

The trend in debt profile has continued to generate concern from stakeholders, which suggestively led the DMO to peg borrowing by the Federal Government at Limit in 2017 at \$22.8billion equivalent to N6.73 trillion.

The debt management agency further discloring this growing trend noted that in 2014, a total of \$346,723, 290 was spent on the same item, while \$297, 329,300 was spent in 2013. In 2012 and 2011, the servicing of external debts cost he nation a total of \$293,003,540 and \$351,619,070 respectively.

The trend has continued this year with \$117,660,770 spent on serving the country's external debt in the first quarter of the year and \$47,998,430 in the second quarter, thereby making a total of \$165,659,200 for the first six man total of \$165,659,200 and.

According the report, the 36 states of the federation and the Federal Capital Territory owe \$3.65billion of the foreign debts, as against the \$7.61bn owed by the Federal Government.

Lagos State, which is the largest economy in the country, owes a total of \$1.43billion. Thus, the state holds 39.17 per cent of the country's total subnational loreign debts.

Kaduna State, with a foreign debt of \$225.28m, comes in the second position. It holds 6.16 per cent of the total subnational foreign debts.

Edő State, with a total of \$179.52million as of June 30, holds 4.91 per cent of the country's subnational foreign debts.

# Chapter 4 MY SECOND PERSONAL EXPERIENCE WITH CORRUPTION AND HOW CORRUPTION IS DESTROYING NIGERIA

And by the way, it is noteworthy to point out that the foremost education research center in Nigeria (NERDC) found the novel so interesting and compelling, in its teachings of peace education, NERDC Director of book assessment Dr. Mrs. Benedict Ikegulu found it worthy to issue an impressive foreword for the novel. This can be gleaned in page 3 of the novel.

This is the kind of novel the academic institution bypassed and adopted a novel that actually narrated a story of a dysfunctional family with issues of depression and marital stress. This was the culmination of my first application.

My second application was bypassed again and this time, even though the novel adopted was not as negative as the first one, yet this novel had no clear virtue to the reader and considering we are living in a very troubled era of humanity, this is like given chalk tablets to a malaria patient, instead of original extra Panadol tablets. So after the CEO reviewed the novel, it was found worthy of application in the NIGERIA academic system. (All correspondence for this academic project are published in this book, as evidence of what transpired). I have so far made three applications to manage this academic project since 2016, but the strange thing concerning my three submissions is that all three dates of submissions have a strange synchronization of dates as

you will detect when you review the documents of correspondencebetween the academic institution and I. The dates of synchronization are circled.

All these three submissions had a mysterious synchronization of submission dates. The first submission was on the 11th of April 2016. The second submission was on the 11th of October 2016 while the third submission missed the 11th by only two days, therefore falling on the 13th of April 2022, therefore making the 3rd submission on 13th of April, 2022, the 11th by approximation. Two submissions fell on the 4th month of two separate years being 11th of April 2016 and another submission fell in April 2022. So in total 5 submissions synchronized mysteriously.. I was not crying for myself or what I may have benefited from the project; I was crying for the numerous students and youths that were counting on me for a better life. I cried many tears of despair because I knew the high hopes these youths placed on me to deliver was shattered. I was crying for the entire students and youths of Nigeria' who were denied the benefits of a vibrant Reading Culture Promotion Program with all the scholarships and fabulous prizes offered in the proposed 500 million naira Reading Culture Promotion Program . I was crying for my son Daniel Samson who called me daddy because I knew the news will devastate him. And it did when I finally summoned the courage to share the bad news with him.

If I remember correctly, the news of the failed application got to me sometime in June or July of 2018. I later discovered that a Principal personality that was instrumental in setting up the Reading Culture Promotion Program in 2013 which in my estimation is a ghost or fake project died at age 68 in 2020 two years after I cried tears of blood.

This personality was a well known politician in Nigeria, having occupied numerous important positions in government, including Secretary to his State government, Minister of State

goodwill as former President of the USA and getting the current President Biden to issue a multibillion dollar contract to supply arms to a nation.

That will be unprecedented in American politics. But that is what happened in the affairs of this academic institution.

This is as brazen as CORRUPTION can ever be; that a Former Minister of State for Education can use his powers and goodwill as a Former Minister of State for Education and get a novel he personally authored adopted by an academic institution he was paid to manage and get paid for the book adoption. There can and will never be any atom of transparency guiding this kind of project, because the civil servant can never and must never serve himself first instead of the public he is paid to serve.

I heard about his passing sometime in June 2021 and it was not until recently in 2022, it suddenly occurred to me that this personality passed on in 2020 only two years after my second application failed in 2018; the year I cried tears of blood. It was in this same year that this personality passed to glory. Could there be something divine about these occurrences? Nobody can fully tell but the Creator, but the timing of the passing is very suspect and while I sincerely condole with the family of the deceased, it will remain in my heart forever the mystery of the timing of these strange events.

So after all the rush to amass great wealth, all of us will go in the same way as this high profile personality. Everybody wants to live a longhealthy and prosperous life, but not at the expense of vulnerable students and youths. 68 years is too young an age to depart from this world, but that is exactly what happened to this high profile personality.

Another thing happened that could also be divine. The CEO of this academic institution that was responsible for setting up this Reading Culture Promotion Program in 2013 soon after I cried tears of blood, found himself drowning in a sea of multiple court cases. He was all over the news for the wrong reasons and when his personal lawyer lost his nerves amidst heavy media scrutiny and the weight of multiple court cases, he simply felt the best thing for him to do was betray his client.

So he started to sing like a bird. He rolled out an eye popping and jaw dropping list of investments of all kinds he personally helped his client to acquire. Some of these high profile investments included hostels and oil and petroleum outfits.

Promotion Program for scholarships and fabulous prizes and below are just a few of the names. What is all this nonsense destroying the mental capacity of an entire nation.

Flashback to the book adoption application I made to this academic institution.

When I met the CEO he assured me that since my novel had passed all assessment screening and since the book inspires peace and harmony in our dear country, he told me after the expiration of the current novel in use he will be happy to adopt my novel. Unfortunately, a few months after this meeting, a new CEO was appointed so I had to return to Abuja to intimate the new CEO of the meetings and verbal agreements I had with the previous CEO.

I informed the current CEO of my dealings with the former CEO and since the adoption of my novel was scheduled to be in that year, 2016, I was visiting to inquire the position and status of my book adoption application.

So I had to wait for two years.

Two years came faster than I expected and I made a second submission for the 2018 academic year. After I met the new CEO in Abuja for the 4th time, I was so happy that at last at last, our youths will be served a dose of peace inspiring novel.

But by this time, I had sent out a series of documents to the academic institution (all stamped received) so they cannot say they did not read the documents. Some of these documents of correspondence with the Academic Institution are published in this chapter in proceeding pages.

To give an idea of the monetary scope of this project aimed at rekindling.

Reading Culture in Nigeria, it amounts to about 1.5 billion naira per two contract and this figure is computed based on the population of youths or students because each youth pays 500 naira per student for the supply of the novel.

His name is Daniel Samson and he sneaked out of Lagos and returned to Chibok against my advice and a few months after he left Lagos, word reached me that my son was dead from river drowning in a river in Chibok.

I was shattered because it appeared to be suicide by drowning based on the way he was talking before returning to Chibok, but I did not pick the warning signs suicide victims give before the act. It may also have been accidental drowning..Nobody is sure and when I called his biological father, I had to be very careful in making my inquiry, because Daniel father's voice sounded like that of a father in great pain.

That was all I gained from trying to serve my country. A DEAD SON.

In the USA reading culture is on the front burner of duties of the President. All United States Presidents and First Ladies have a duty and mandate to constantly keep promoting Reading Culture and it was very evident during the World Trade Center bombing in 2001.

President Bush was at a Reading Culture Promotion event in

America Government can never take the trouble to fly the President to a primary school far away in a small town called Sarasota if American Government did not see the great importance and value derived from a nation with a healthy reading Culture.

Authorities turned serving the people into serving their bank accounts. Authorities began to see civil service as show business. Glamour and pump creped into civil service. Glamour and pump is only sustainable with money. I mean stolen money. I mean Public funds. Civil servants evolved into kings and gueens that drove in motor convoys and the party culture and buying luxury homes in America and Europe took centre stage and indeed our authorities lost interest in so many great commonsensical aspects of nation building.

That is why the Nigeria' Economy collapsed, for this and a multitude of other reasons.

Did this provision list make you scratch your head? Tap your fingers in deep thought or laugh? Did this list make you angry, worried or nonchalant? If Nigeria academic standards is moving in the trajectory it is in now, then in another 50 years, which will come faster than you expect, people will be dying in hospitals because all we will have are doctors with degrees and no medical skills to save lives.







But today, we are witnessing another kind of tyranny with the total collapse of the Nigeria economy during the waning days of the Buhari led administration. Let's now delve a little bit into the Abacha led administration history.

Birds of a feather flock together is an age old adage and if you decide not to call a spade a spade, just endeavor to digest the preceding paragraphs and you may figure why Nigeria' is the way it is today and what I mean by the proverb": birds of a feather flock together"

The Abacha military regime that ruled Nigeria from 17 November 1993 to 8 June 1998 could well be summarized as a government that was involved in a perennial, if uneven, struggle with civil society organizations and the international community that wanted a rapid return to civilian and democratic rule. The Abacha junta, which was the arrowhead of the anti-democratic forces, prevailed, by substituting 'the edict of the gun' for 'the promise of a new dawn'. The resilience and perseverance of the pro-democracy forces, with a tinge of providence, ensured that the Nigerian civil society had the last laugh.

Abacha received his formal military training at Nigerian and British military training colleges. He rose through the ranks in the Nigerian military and by1983 had achieved the rank of brigadier when he assisted Ibrahim Babangida in overthrowing Shehu Shagari, who had beenelected to his second presidential term in 1983. Muhammad Buhari became Nigeria's leader, but just two years later Babangida overthrew Buhari and installed himself as leader with Abacha second in command. Elections were held in 1993 and were won by Moshood Abiola, a candidate supposedly supported by Babangida, who, however, annulled the elections and set up a civilian interim government, which Abacha quickly overthrew.

Although Abacha promised a return to democracy, his actions were anything but democratic. He banned political activity of any kind, fired a large portion of the military, controlled the press, and assembled a personal security force of some 3,000 men. While he supported the Economic Community of West African States (ECOWAS) and its military arm, ECOWAS Monitoring Group (ECOMOG), in sending troops to restore democracy in Liberia and Sierra Leone, he brutally suppressed dissent at home. Abiola and Olusegun Obasanjo, a former military leader of Nigeria (1976-79), were jailed for treason. Wale Soyinka, Nigeria's Nobel laureate, was also charged with treason, although he had voluntarily left the country. Perhaps Abacha's most brutal act was the imprisonment, trial, and subsequent execution for treason of writer Ken Saro-Wiwa and other Ogoni activists who were concerned with the environmental exploitation of their region by multinational petroleum companies.

Abacha's sudden death in June 1998 moved along the process of returning the country to civilian rule. His military successor, Abdusalam Abubakar, oversaw the return to an elected civilian government in 1999. After Abacha's death, it was rumoured that he and his family had enriched themselves by some \$3 billion, most of it held in European banks. In 2002 a settlement, which returned most of the money to the government in exchange for dropping criminal prosecution, was reached between the Obasanjo government and the Abacha family.

It was this blanket of darkness in Nigeria that gave rise to formidable pro-; democracy movements like CLO and many others. CLO was one of the most effective weapons fashioned against military dictatorship under the watchful eyes of Olisa Agbakoba who happens to be my beloved elder brother. So I know the whole story of his activism. I was enjoying a bowl of pepper soup and a chilled beer in a lounge when the kind of news you don't want to hear, especially when you are enjoying a quiet evening with a few friends suddenly pops from the blues.

Olisa Agbakoba has been arrested by Abacha security operatives on his way back from Germany where he visited to share the true state of things in NIGERIA and canvas for additional support.

The rest is history as I sped to Olisa's home at Illorin Street in Surulere to consult with Lillian, Olisa's wife on what was really going on. Lillian confirmed to me that Olisa was picked up at the airport on his return from Germany and has since been moved to the Enugu Prison

It was rumored that Olisa and a couple others where on Abacha's hit list and because Abiola and Yaradua died under mysterious circumstances not still very clear to this day, this was a rumour that was given everybody what came to known as "Abacha fever."

We heard nerve chilling rumours of statements made by Abacha in private. He said boastfully "that Igbo lawyer thinks he is so smart. He got away from me at Yaba, this time he can never escape."

However, Olisa escaped the gallows of Abacha when it was reported he was having some private pleasure when he kicked the bucket. This was just a rumour like a smoke, but we know there is no smoke without fire, so there must have been some fire to this smoke or rumour. As the three Prison inmates approached wing C, their worst nightmare was confirmed, as they could hear the voice of Olisa in heated argument with Abacha security operatives.

Holy Moses. He is here O!; Lord have mercy on Nigeria'. We are doomed!! "one of the activists exclaimed.


Please stop using that word 'doomed' it gives me the jitters.

Every day we prepared our minds to hear the bad news. "Olisa committed suicide" Olisa had a heart attack. Olisa fell off the prison balcony. Olisa was bitten by a snake in his cell and so on. Imaginations were running wild.

Egypt it is discovered has been used as a place of refuge, comfort and information seeking since the age of Israel living in Egypt, over 2000 years ago when Joseph was Prime Minister of Egypt and just two point out Joseph the son of Isaac received intense training in politics in Egypt, little wonder, Peter Obi also touched base with Egypt in recent times.

There are similarities between Peter Obi's Ascension to Egypt and notable Biblical and Koranic characters and events and in legal terms this is referred to as Precedence and Precedence simply means, if it happened before, it is most likely going to take the same course today as history reveals.

These are all vocations and one of the 12 apostles was reputed to being a medical doctor. 2000 years ago, there were nations and governments and hospitals and doctors and indeed there were also a host of all kinds of cultural activities such as sports just as is apparent today.

So 2000 years ago, the presence of all these activities that are the basis for our common humanity were all present as is still the case today. Reading culture is a very important component of developing a progressively developing nation. Youths will never develop a healthy reading culture only by attending secondary school and higher institutions. It is a deliberate effort made by parents in the home and institutional projects from academic institutions that kindles a healthy

reading culture and let's not deceive ourselves, reading culture has almost totally collapsed in developing countries like Nigeria, It will take many years of deliberate effort from parents and academic leaders to rekindle this progressive academic, social culture. No starting point to begin to rekindle reading culture is too small or too big to start, after all the journey of a thousand miles starts with the first step.

Youths carry smart phones in their pockets that cost 40,50,60,70 or even 80,000 naira and above, but will not spend 1,000 or 1,500 naira to buy a good book. So money or its lack thereof is not the problem.

In the 60s, 70s and early parts of the 80s, novels of the Hardly Chase series, Mills and Boon or the Sidney Sheldon series amongst many other titles were very popular amongst Youths including my humble self. But today all we see is youths and even adults bent over their smart phones sending all kinds of messages, many of them useless to mind building. This has to

be and can be reversed with adequate support, encouragement and resources. Platforms that encourage book reading culture need to be created as a matter of urgency with adequate incentives that inspires reading.

Compelling a Youth to buy and read a book to pass an exam is a good starting point, but simple psychology informs me that the minute that pressure to buy and read a book to pass an examination is absent, then the book will most likely be discarded.

The whole idea of igniting reading culture is to ensure that youths willingly look for good books that may interest them and read such books without any coercion or pressure because they want to pass an exam, like it used to be in the 50s, 60s, 70s and early part of the 1980s.

When we observe families in developed nations, we wonder why everybody from the little toddlers to teenagers plus dads and mums always have a novel, story book or nursery rhymes they are reading in their spare time.

There is a definite benefit to this culture that enhances and accelerates societal development. It's interesting to note that the industrial revolution of the 1900s that was the bedrock upon which industrialized nations began to emerge was not inspired by people who received formal education in institutions of higher learning.

It was inspired by people gifted with vocational skills who never saw the 4 walls of any university. However, these gifted people that gave us all kinds of inventions that has made life easy and sweet today did not have the capacity to translate their innovations of inventions into public utility. The people who had acquired formal educational were the administrators and technocrats that had the training and skills to transform innovations and inventions often developed in backyards and garages into usable products, utilities and services.

As I mentioned earlier, it is a healthy balance It is a healthy balance of the 3 major mediums of education that accelerates development, prosperity and general well-being of a nation, just as the human body needs a healthy balance of proteins, carbohydrates and vitamins/minerals.

Industrialized and developed nations did not become developed through any mysterious magical powers. Any nation that applies some of the principles industrialized nations have adopted for centuries will have the same results.

It is little wonder that when the President of the United States of America or the US First Lady visits a primary school, reading story books to the President or the President reading to an entire classroom is an event high on the activities of the visiting dignitary. And of course, news networks like CNN are always on hand to broadcast the event to the entire world.

This activity is designed to promote reading culture. It is a fact that during the 9/11 bombing of the World Trade Center in new York, President Bush was in a classroom reading to students while the students also read to his hearing. A CIA operative came into the classroom unnoticed and whispered into the President's ears that America was under terrorist attack. President Bush did not abruptly stop the reading exercise but took another 15-30 minutes to round up nicely before attending to terrorist attack issues facing America at that very moment. This singular action speaks volumes concerning the importance of reading culture and this fact is still on the internet for anybody to verify. Polices that introduce compulsory literature books for all exam candidates to help rekindle a dead reading culture most apparent in Nigeria and beyond is a fantastic policy, but I firmly believe that authors and publishers can play a vital role to help support this policy.

How can this objective be achievedWe all know that youths and students will readily wish to take advantage of scholarship opportunities if available and if presented via accessible and reputable platforms, youths or students who are interested in such scholarship funds or other attractive prizes must show proof of having read at least 2 or 3 novels apart from recommended examination books to be eligible to apply for the scholarship and prizes executed after exams are done with. The degree of literacy decay has reached such an alarming stage, that we can no longer be complacent as our youths and students have almost totally abandoned interest in reading good books that edify the body, soul and spirit to browsing for all kind of junk information that defiles the mind, readily available on the internet and social media. Our children can hardly spell correctly even the most simplest of words and this is one of the many disadvantages of a dead reading culture.

We must as a matter of urgency, do all in our power as leaders, teachers, lecturers or professors to help salvage a dead reading culture in Nigeria and beyond, before we begin to produce Lawyers that cannot write briefs or teachers who cannot spell correctly.

We in Nigeria may think we are losing revenue from obvious areas such as our inability so far to drill and refine our oil or tons and tons of precious minerals including gold and silver that remains buried deep in the earth or inefficiencies of a potentially vibrant tourist industry, however we are losing tons of revenue from less obvious areas such as book sales.

For instance in Fareed Zakaria's CNN Program Global Public Square (GPS) Fareed reported on the 23<sup>rd</sup> of April, 2018 that a survey was conducted by a reputable survey organization and it was revealed that out of the American population of 325.7 million people only 60 Million people didn't read at least two books last year 2017. This means that a balance of 265.7 million people read an average of three books and above in 2017. This analysis should get us on our feet to change the course of reading habits in our dear country. It can be done and all we have to say to ourselves, if I may borrow a quote from Barrack Obama when he was on the campaign trial "yes we can"

These figure translates to Trillion of Dollars in revenue from a book Reading Culture possibly larger than the Nigeria annual budget.

If we in Nigeria could successfully install democracy or even build a brand new capital from scratch in Abuja, within the span of a few decades, then we can safely say that we in Nigeria can achieve anything we have a collective resolve to achieve.

The question begs, "What is holding us back"

### Chapter 9

From time immemorial, names and naming ceremonies has been an intrinsic part of our common humanity. In some cultures, in Africa and indeed Nigeria, naming ceremonies are very sacred and celebratory occasions very much revered.

Stories of name change abound in the Bible and Koran and should act as a guide to Nations who may be eying the prospects of name or identity change. Why was this change in names of two principal characters in the scriptures become so important?

When God had plans of making Abraham the father to many Nations a change of name became eminent and the same prescription was administered to his wife Sarah, because the two new names carried the precise meanings and vibrations needed for the mission of Abraham and his wife Sarah in becoming father and mother to a multitude of Nations.

In Bible and Quran stories, Blind Bartimaeus tore off his old tattered clothes and put on fresh bright clothes when he suddenly got healed from total blindness. Meaning his newly regained sight demanded a fresh new Identity, hence the urgent need of a sudden change in clothes, appearance or identity.

Saul of Tarsus was a violent and effective prosecutor of the early Christians, but when the Creator had plans to convert Saul to a major personality that did spreadsheet the Gospel, God changed his name from Saul to Paul.

One of the earliest examples of name change is found in the Bible and Koran when God Himself changed the name of Abram to Abraham and also changed the name of Saria Abraham's wife to Sarah. It is very clear that name has a lot to do with fulfilment of destiny. There are numerous instances of name change in the scriptures and there seems to be a striking similarity between the meanings of African names and how such names are given with meanings of scripture based names and how such names were given and the following are a list of some scripture characters and the meanings of the names.

People whose names were changed by the Creator in the Scriptures and the meanings and significance of such names.

Here are some of the people whose names were changed in the Bible or Koran Jehovah himself gave the name to Abraham and Sarah.

Abraham – The word Abram Means Exalted father and Abraham means father of a multitude. Bible says in the book of (Genesis 17:5) "He shall no more be called Abram, his name shall be Abraham; a father of many generations have I made thee."

Sarah – The word Sarai means princely and Sarah means queen of princes or mother of princes. (Genesis 17:15) "God said to Abraham, you shall not call your wife Sarai, but Sarah shall be her name."

In the story of Jacob an angel came to him and changed his name from Jacob to Israel.

Jacob – The word Jacob means cheater, deceiver, and Israel means God's people. (Genesis 32:28) "And he said, your name no more shall be called Jacob but Israel. For as a prince hast thou power with God and with men, and hast prevailed."

Mishael, Hananiah, Daniel, Azariah here Ashpenaz changed the name. Daniel – The word Daniel means God is judge and Belteshazzar means the chief deity of Babylon.

Hananiah – The word Hananiah means gift of the lord and Shadrach means command of Aku, The moon God.

Mishael – The word Mishael means who is what God is and Meshach means who is as Aku.

Azariah – The word Azariah means whom Jehovah helps and Abed-nego means the God of science and literature.

(Daniel 1:7) "The prince of eunuchs gave names: he gave unto Daniel the name of "Belteshazzar", and to Hananiah of "Shadrach"; and to Mishael of "Meshach"; and to Azariah of "Abednego"". Did these change in names prepare then spiritually to defy the hot coals of fire they were thrown into?

Nebuchadnezzar changed the name Mattaniah to Zedekiah Mattaniah – Meaning of Mattaniah is Gift of YAHWEH. And the meaning of Zedekiah is "The Lord is righteous"; God's justice. (2 King 24:17) "And the king of Babylon made Mattaniah, Jehoiachin's uncle, king in his place, and changed his name to Zedekiah.

Moses changed the name of one of his very close confidants from Hosea to Joshua.

Hosea – Meaning of Hosea is salvation. And Joshua means Jehovah saves. (Numbers 13:16) "And Moses called Hosea the son of Nun Joshua."

Pharaoh changed the name of Joseph to Zaphenath-Paneah Joseph – Meaning of Joseph is May Jehovah add\give increase. And Zaphenath-Paneah means Egyptian for God speaks; creator of life. (Genesis 41:45) "Pharaoh gave Joseph the name Zaphenath-Paneah and gave him Asenath daughter of Potiphera, priest of on, to be his wife.

Jesus changed the name of Saul to Paul

Saul – Meaning of Saul is asked for, prayed for. And Paul means little or small. (Acts 13:9) "Then Saul, (who also is called Paul) filled with the Holy Ghost, set his eyes on him.

11 Countries That Changed Their Name and the varying dynamics that informed name change

Due to land divisions, wars, changes in government, independence, or simply to facilitate pronunciation abroad, some countries have decided to change their names. In some cases, they did it many years ago, and we know these countries by their current name. But others did it very recently, and we still find it challenging to call them by their new name. The process of modifying a country's name isn't simple, much less economical. But despite it all, various parts of the world have dared to do it. Because it was the sensible and proper thing to do.

### 1. Holland changed to The Netherlands.

As a marketing move, the government decided that from January 2020, the official name of the Netherlands would be used for promotional purposes instead of Holland. One of the reasons for this change is to "present the Netherlands as an open, inventive, and inclusive country."

### 2. Ceylon changed to Sri Lanka

Ancient Ceylon, modern-day Sri Lanka, changed its name that was given by the Portuguese when they discovered it in 1505. It later became part of the British Empire and gained its independence in 1948. However, it was years later that the island's government decided to make the change. In 2011, all references to Ceylon, from official bodies to companies that still carried the old name, were removed.

# 3. The Republic of Macedonia changed to the Republic of North Macedonia.

The former Republic of Macedonia changed its name to the Republic of North Macedonia in February 2019. The main reason for the change in name was to become a part of NATO, and also to distinguish itself from its neighbor, Greece, which has a region named Macedonia. The inhabitants will continue to call themselves "Macedonians," and the official language will remain "Macedonian0

# 4. Czech Republic changed to Czechia.

In order to facilitate the naming of the country at sporting events, as a part of companies' marketing efforts, and in the rest of the world, the Czech Republic shortened its name to Czechia It happen very recently. It was established in 1939 by the king who ruled the country at the time. In the local language, the name is pronounced Prathet Thai, which means "the country of free people," and it pays tribute to the first settlers who arrived seeking freedom from China.

name, in April 2016. The measure had been discussed for 20 years until, finally, it was decided to shorten the name so that pronunciation would be easier in each of the country's 6 official languages: English, French, Russian, Chinese, Spanish, and Arabic. Although the official name will still be the Czech Republic, Czechia has become the shortened official name of the country.

#### Swaziland changed to Eswatini

In April 2018, the king of Swaziland, in Africa, issued a statement declaring that the country's name would change to Eswatini. The modification didn't surprise its people since that was the name they were already using. Eswatini is just the translation of Swaziland into the local language, which means "land of the Swazis". Besides, the old name was confusing, since many mistook it for Switzerland.

# Alto Volta changed to Burkina Faso.

To celebrate the twentieth anniversary of its independence, the Republic of Alto Volta was renamed Burkina Faso, which, in the local language, means "land of whole men." The change was made in 1984, along with the alteration of the flag and the national anthem. The previous name referred to one of the main rivers in the region.

#### 7. Burma Changed to Myanmar.

In 1989, the country's leading military government was determined to change the name from Burma to Myanmar in an attempt to preserve the way it's written in the local language: Myanma. However, not everyone agreed with this decision. For this reason, some parts of the world still insist on referring to this Asian country as Burma.

It is not a matter of having a clean slate. The Constitution, official stationery, and even money has to change as well. Everything that bears the country's old name, like maps, flags, and hymns, must erase it and replace it with the new one. This, of course, takes time.

We can see from this discussion that Nations change their names for a variety of reasons all addressing nation building of the respective Nations for each nation must have a unique prescription to suit her history or aspirations.

In Africa many Nations changed their names after regaining their independence and notable of such countries is The Gold Coast now known as Ghana or Rodassia now known as Zimbabwe but the most conspicuous reasons why name change should come with identity change is found in the scriptures.

The scripture stories of Jabesh tells of how a great famine and hardship befell the people of Israel and at that time of hardship, a baby was born to a family and the parents felt it would make a good idea to name the new born baby "Jabesh" meaning he or identity change that must not be overlooked. was born in times of HARDSHIP. It is recorded in the scriptures that as Baby Jabesh grew into a boy and man, all Jabesh experienced was one calamity after the other until he began to ask some deep questions and that is when he discovered that his name meant calamity and hardship. Jabesh cried out for a change in his name and later rose to become one of the most prominent administrators in scriptural times.

The story of the prodigal son in the scripture tells of how important identity change is because when the prodigal son realized his greed and foolishness and decided to return to his father's house, when his father sighted him from afar as he returned, he rushed to welcome his son and the first thing he said is "discard his torn clothes and bring out the purple robes and cloth him and adorn his fingers with a gold ring.

There is more scripture based citations on the issue of name or identity change in the scriptures, but this will do for now and the conclusion we should take home is there is something mysterious about name.

The name given to us as NIGERIA has an interesting history as to how the name came about. Mrs. Lugard, wife to the very first Governor General of Nigeria was the lady who gave us the name NIGERIA and as discussed in previous Chapters, the great River Niger was what inspired Mrs. Lugard to coin the name NIGERIA from the name of a River that took its source from the Futa Jallon mountains. Needless to say the River Niger and other rivers where the much needed sea routes that made high volume exploitation and transportation of our precious produce and minerals possible. Destination? Great Britain! The British Empire. 9. German South West Africa changed to Namibia.

When the country became independent from Germany, it was renamed Namibia. This happened in 1990. Sometime later, the names of cities and regions that were in German were also changed. The citizens didn't like the proposal at all since they were already familiar with the old names.

# 10. Cape Verde changed to the Republic of Cabo Verde

Another recent change was the one from Cape Verde, which took place in 2013. The country's name is now the Republic of Cabo Verde, or simply Cabo Verde, which is what the Portuguese sailors who discovered the islands called them, in 1444.

## 11. Irish Free State changed to Ireland.

In 1937, with the intention of removing all ties to the United Kingdom (with whom the country had a fierce war for 2 years), the Irish Free State became Ireland, or Éire, in the local Irish language.

# How much does it cost to change the name of a country

Most of the countries on the list switched their name as a way of erasing part of their past and getting closer to their true identity, while others did it to encourage tourism, like the Netherlands. However, not everything is as easy as it seems. And it's not cheap either. Each nation paid millions of dollars, or its equivalent in their local currencies, to change its We can all see that Mrs. Lugard must have been inspired by exploitation amongst other reasons while giving the name NIGERIA. If this theory is valid, this simply means we are still wearing the garment of exploitation and corruption and this garment comes in the form of the name NIGERIA several decades after independence in addition to other negative garments like bad Governance and Corruption inherited from our colonial Masters. These are sucking the oxygen out of progressive development in Nigeria or Africa.

In Africa Culture it is the father that issues a name for the most part but not to say that the mother has no input. It is abnormal for the wife or mother to be the Principal name giver as experienced with the name NIGERIA given to us by a British Lady Mrs. Lugard had no business giving NIGERIA a name because it is not our cultural or spiritual practice.

Edo kingdom is one of the oldest African/NIGERIA kingdoms and the following description of a naming ceremony is how we know it in Africa or NIGERIA. The father or husband is the sole person that provides a name for the new born baby and not the mother or wife so Mrs. Lugard had no business giving any African country a new name. It is not our custom. Could this little mystery of paternal or maternal name given be part of the problem?

#### THE EDO NAMING CEREMONY

The Edo tribe is an ethnic group largely found in Edo State, Nigeria. The Edo are descendants of the great kingdom of Benin, also distinguished by the richness of their fabrics and their fashion accessories – intricate and colourful beads, bracelets, necklaces (the colour orange is predominant) and anklets. The kingdoms of Edo and Oyo (Yoruba land) were the two most powerful kingdoms on the west coast of Africa; although their 'kingdoms' no longer exist the way it used to be but the legacies of these kingdoms, in the form of traditions and practices, still exist.

In the Edo African tradition of naming a child, the same symbolic food items used in the Yoruba Ikomo are also used; however, some items may appear on the list of foods that are not typically found in the Yoruba naming ceremony: gin (so the child will not become a drunkard), yam (that the child will enjoy a hunger-free life) and coconuts (as coconuts need to be broken to reveal their goodness, so the child will be able to 'break' through problems to find their solutions). The ceremony takes place on the evening of the seventh day after the birth of the child. Early in the morning, the elders of the community and close family members consult oracles to pray for the child and the child's parents.

In the actual ceremony, men and women sit on separate sides of the room where the event is being held. The mother usually holds her child, beautifully dressed (of course, she's Edo!). Nuts are broken and shared, and the gin is served. The mother is asked to reveal the name her child is to be called. She has asked this same question a total of seven times. The first six times she is asked the question, she deliberately gives the 'wrong' name – she will offer silly-sounding names as a joke – and her given names are, therefore, not accepted. At the seventh attempt, the father of her child whispers the 'correct' name to the mother who then declares the correct name, i.e. the one given to her by the father of her child. This is met with rounds of applause. The ceremony is eventually brought to a close with the African tradition of prayers for the child, food, music and more good wishes for the family.

You can see from the preceding paragraph that the father or husband has the final say what name the baby will bear.

We can also see that name giving or naming ceremonies are very sacred ceremonies that involves certain rituals and prayers and if we in Africa can attach so much importance to name giving for just one baby, how much more importance will African people give to naming an entire nation with a population of millions of people. The truth is that the name NIGERIA was simply shoved down our throats weather we liked the name or not. It is possible Mrs. Lugard came up with the name Nigeria very casually while having dinner with her husband and felt it will be good to honour the river that made exploitation easy and efficient. Names are not just randomly picked but carefully selected to bear witness to the aspirations of the particular nation and not to open old wounds for these wounds of exploitation meted to NIGERIA by our colonial Masters will never heal completely if the vibrations of exploitation embedded in the name NIGERIA still exist. These negative vibrations need to be exorcised

and these negative vibrations are hiding in the name NIGERIA.

Therefore, it is not a normal African practice for the wife or mother of a child to issue the name and therefore Mrs. Lugard had no business issuing the name 'Nigeria' that was inspired by exploitation of the River that transported the goods that enriched the British Empire. If there is anything like name DNA, then it will be safe to say that the DNA of exploitation is still embedded in the name 'NIGERIA' and if that is correct, no wonder Nigeria has so far always struggled to develop for we seem to be exploiting ourselves as we have experienced with corruption and bad governance lately. Just a carbon copy of what our colonial Masters did to us, we are now doing to each other and possibly in greater doses.

In contemporary Spiritual thoughts, the high priest will say this kind of behavior will greatly anger the Gods and when the Gods are angry, according to African beliefs, then the land will not yield. Could this be part of the problem in Nigeria's anaemic development since 1960?

Name change may sound trivial in the ears of some people and that the issue is too insignificant to matter, however, we have heard of cancer patients who were healed but some very tiny cancer cells were not detected and after enjoying a cancer free health for 13 years the cancer returned with a vengeance because the doctors failed to detect a few cancer cells hiding in the body 13 years earlier. This could be a possible scenario for NIGERIA moving forward if name change is not implemented. Permit me to create a hypothesis to help drive home the point of the importance of name change.

In 1855 just before the official end of the transatlantic slave trade, a village in present day Ghana was raided and 67 young boys were kidnapped and sold into slavery and subsequently exported to an American pinewood plantation.

All 67 boys, with ages ranging from 6 to 15 years were given brand new names by their slave Masters who found it difficult pronouncing African names and for the next ten years these boys worked as slaves in an American pinewood plantation.

However, the boys were freed after being in captivity and were all returned to their parents and motherland in Ghana.

On return to their native lands and bearing strange names given to them by their slave Masters, if you were the parent to any of these boys, commonsense tells me the first thing the parent will do is to annul the slave name and replace it with a name given by the parent or parents of the son. It's that simple and this is what our Post-Colonial leaders should have done in 1960 when Nigeria regained her independence.

Therefore, having discussed how names are given, why names are given and who is supposed to give names, we can all see that the name given to us by Mrs. Lugard is most inappropriate and besides, it appears to me that the great African resources being pumped out of Nigeria and indeed Africa could not be possible without the blessings of the River ways of the River Niger, hence Mrs. Lugard deemed it fit to give NIGERIA a name that reflected the benefits gained from the waterways of the River Niger. Just like to honour or appease the spirit of the River Niger for all the ferries, canoes and ships that ply her waterways carting away our precious produce and minerals.

If there are any arguments in favour of why we should retain a Colonial name that smells of corruption and exploitation, I will be very pleased to review.

I propose the Federal Government look into this issue of name change by setting up a committee of Spiritual and secular scholars drawn from all Geo political zones to study the prospects of name change for this may be one of the unseen problems in Nigeria of why we are so richly blessed but yet so poor over 60 years after independence.

No therapy to repair Nigeria is too much sacrifice, so if wearing the garment of a name inspired by corruption and exploitation is part of the problem in Nigeria, then name change should be put on the front burner because the NIGERIA economy may rebound, only to slide back into recession again if the issues discussed concerning name change are not taken seriously.

And finally to conclude, you may want to know how I come about these issues of spirituality and philosophy.

I really do not know how these matters enter my spirit to the level I am so convinced of my writings, it became imperative to Publish a book on these multitude of issues concerning the History of Corruption in Nigeria, name change and other topics discussed in this book. #### We have all heard of the deep cutting racial slur "Nigger"

Nigger is derived from the Latin word for the colour black, Niger. According to the Random House Historical Dictionary of American Slang, it did not originate as a slur but took on a derogatory connotation over time. Nigger and other words related to it have been spelled in a variety of ways, including niggah, nigguh, niggur, and niggar. When John Rolfe recorded in his journal the first shipment of Africans to Virginia in 1619, he listed them as "negars."

Nigger is an infamous word in current English, so much so that when people are called upon to discuss it, they more often than not refer to it euphemistically as "the N-word." In senses 1 and 2, the word ranks as almost certainly the most offensive and inflammatory racial slur in English ever created by mankind, a term expressive of hatred and bigotry. Sense 3 is also now rarely used and is often considered offensive. The word's selfreferential uses by and among Black people are not always intended or taken as offensive (although many object to those uses as well), but its use by a person who is not Black to refer to a Black person can only be regarded as a deliberate expression of contemptuous racism and has been embedded and engrained especially in the American social culture.

There is a widespread belief that the original meaning of nigger, as defined in dictionaries, was "an ignorant person," and a related belief that current dictionary definitions describing its use as a hateful, racist epithet are a recent change. We do not know the source of those beliefs, but they are not accurate. The word was first included in a Merriam-Webster dictionary in 1864, at which time it was defined as a synonym of Negro, with a note indicating that it was used "in derision or depreciation." This is some history on how the word nigger ever came about.

The word Nigger took root as a terribly offensive word during the centuries that saw the flourishing of the Trans Atlantic slave trade that spanned several centuries dating back to the 12th century and was officially abolished in 1856.

The word Nigger became a favourite name of suppression and oppression from the white slave Masters to their black slaves and was often used to inspire more grinding hard work from slaves " move it on nigger, faster nigger, we ain't got all day, Nigger better move your ass " and so on.

With every passing generation of black slaves, the racial slur became more potent and evil to even mention, but that was all the black slaves ever heard from their slave Masters and even children of slave owners did not spare the slaves any atom of dignity. Whenever a slave was found wanting in work performance, the word nigger is used as a correction stick.

Incidentally, the slaves also generated a racial slur for their White Masters. The word mother-f--ker evolved out of the American plantations.

Most slave owners were serial sex offenders that were notorious for raping black slave mothers who were married to fellow black slaves and these were mothers that even had family and children, so as this anti social behaviour evolved into a culture that beautiful black ladies and girls had to be used as sex toys, the racial slur evolved out of the plantations. Indeed, the white slave owners found the word terribly offensive. Some slave owners were reputed to have hung black slaves to death for directing the word Mother-f--ker to a slave Master for sleeping with his wife or mother. This therefore was the atmosphere that generated the word "nigger" It was a most undesirable atmosphere for any human being to exist.

By the mid 1800 when the Trans Atlantic slave trade was officially abolished, (even though it continued in numerous pockets) liberated slaves were being returned to Africa in shipload. Some slaves who still knew exact areas of Africa especially West Africa they came from, returned to their respective motherlands, however, there were millions of slaves who had lost information of their motherlands, so such slaves were dumped in present day Sierra Leone and the area was appropriately named Freetown and bears this name even till this day.

It was around this time before the adventures of Mongo Park and other explorers that the name River Niger began to be heard as the name of a great River that flowed through the entire span of West Africa.

It was first called the Nigger River then later somehow it was turned around to River Nigger and later the spelling dropped one of the Gs in the word Nigger and that's how we arrived at the River Niger. In addition the pronunciation of the word 'Niger' changed to its current form

This therefore is the history of how the River Niger got her name. It was a name inspired by the blood and sweat of Africans slaving in American and European plantations and factories. There is so much similarity in the word African Nigger to River Niger, there is bound to be a connection to the evils that transpired in the plantations and factories of America and Europe for centuries to the name River Niger. In 1914 NIGERIA was created in what is known as the amalgamation of North and South Protectorates and it is in history that Flora Shaw, the Mistress to the very first Governor General of NIGERIALord Lugard issued the name NIGERIA.

What inspired Miss Flora Shaw to give us the name NIGERIA has been discussed in this chapter and Flora Shaw must have been knowledgeable in the history of how the River Niger got her name because in the early parts of the 20th century, the word Nigger was a very terrible word, actually a taboo never to be directed against anyone of colour and our Colonial Masters came never deny they were oblivious of the negative vibrations the word nigger generated. They cannot deny also that they failed to notice the striking similarity between the words Nigeria to the word Nigger. Even a ten year old English student will figure this out.

However, Flora Shaw must have been so carried away with great blessings the River Niger bestowed on the British Empire because the River Niger was the river ways that transported our precious produce and minerals to the ocean going ships waiting in the Delta regions to ferry our wealth to Britain.

This in a nutshell is the history of the origins of how we were given the name NIGERIA .It is a name soaked in centuries of slavery and exploitation dating back to days of the Trans Atlantic slave trade that lasted for 400 years right down to British Empire exploitation of NIGERIA dating back officially to 1914 when NIGERIA was created.

Is this the kind of name we want to retain now that the truth of how the name evolved over many centuries has been revealed? There is certainly the DNA of slavery and exploitation still embedded in the name NIGERIA and the discussions we have had in this chapter, explains in some detail the Dynamics of name giving and name changing which has also even been a Devine pattern of action from the days of Abraham and Jacob by the Creator God.

So why is it different in Nigeria, but suffice to say, it is not late because I have no doubt in my mind that the name NIGERIA has been part of the problem in Nigeria's lack of development because the only thing that has seemed to have greatly developed in NIGERIA is Corruption, exploitation and bad Governance.

The very same thing the British Empire did to us, we are now doing to each other because when the baton of power passed into the hands of our post Colonial leaders like NnamdiAzikiwe, Tafawa Ballewa and Awolowo, it was surly laced with the DNA of Corruption and exploitation. It's Spiritual and it's a mystery why these things work the way they do

If there are any schools of thought that can refute that name is not part of the NIGERIA problem, let them carefully study this chapter for it will make sense after awhile or come up with why name change is not part of the problem for we have become a carbon copy of our colonial Masters corruption and exploitation upon us.

A typical example of the enemy- inner-me for the enemy is within us. We are our own enemy.

# HISTORICAL SUMMARY AND METAMORPHOSIS OF HOW THE NAME NIGERIA CAME INTO EXISTENCE

Nigger was the Latin word for black and it was not designed as a hedious racial slur by the owners of the Latin language

When the Trans Atlantic slave trade was in full swing, the word Nigger evolved into slogans of hatred and bigotry and several hate slogans were composed. "Move your slow ass nigger; nigger you better move or I kick your ass; nigger you ain't working fast enough" and so on.

When the Trans Atlantic slave trade was officially abolished, slaves were returned to Africa by the shiploads and the River Niger was one of the major River ways that facilitated transportation of slaves to their original motherlands after arriving in Freetown or current day Sierra Leone. The mass exodus of returnee slaves plying the river generated the name "Nigger River" took root and was later turned around to River Nigger and later again the word 'G' was deleted from the word Nigger and that's how we arrive at 'Niger'.

Therefore it is clear that the Trans Atlantic slave trade inspired the name River Niger.

In 1914, Flora Shaw the wife or girlfriend to Lord Lugard issued the name NIGERIA and while she may not have been directly influenced by how the name was originally generated in the American slave plantations, yet it was the great blessings of exploitation and looting of NIGERIA by the British Empire that inspired the name NIGERIA as a coinage from the words River Niger. After all, the River Niger was the river ways that made high volume transportation of our precious produce and minerals possible.

How can such epic blunder be perpetuated without noticing the striking similarity of the name NIGERIA to Nigger or Niger.

Will any parent name their new born baby DEVILL or DEVVIL because the name DEVILL or DEVVIL and DEVIL are just too similar. Can any parent name their child *monki* or *monkky* because these two names are spelt just like monkey apart from the double k or I instead of monkey. No parent will give their new born baby a name that spells or sounds like "monkey". Will any parent give their baby boy this name *HITTLER* or *HITLLER* because even though there is a minor spelling variation, even a goat will realize this name sounds too similar to the notorious Dictator Hitler.

So how come the striking similarity of the name NIGERIA to NIGGER or NIGER went unnoticed? It was noticed and was just a take away of a hideous name to implant the name in Africa forever using naming of a famous river after an infamous name that was nurtured with hatred and bigotry when the White people thought we were just a little better than the horses that ploughed their plantations.

Niger or NIGERIA sounds and spells too similar to Nigger and if this was not deliberate then it was unconsciously deliberate.

A name having this kind of historical mix-up is not the kind of name the people of NIGERIA should be cloaked with because weather we know it or not and whether we like it or not, we have been maliciously cloaked with a Spirit called corruption, exploitation and bad governance until we come to a revelation to that fact we may very well be paddling the NIGERIA canoe against the river currents of all kinds of dynamics that counter effective nation building and could be part of the problem why corruption and bad governance has run a mock in Nigeria.

Social scientists are still very puzzled why in the family of West African States known as ECOWAS, Nigeria is the only lone Nation that still bears the name our colonial Masters thrust on us over 60 years after independence.

On a closer study of the subject of name change, let us come closer to home and discuss West African countries that effected name change as soon as independence from Colonial Masters was attained to begin to understand the issue of, why is it different in Nigeria?

Togo was formerly a German Protectorate called German Colony of Togoland until 1914 when the French and British troops invaded.

In 1894, Riveres du Sad, Cote d'Ivoire and Dahomey were separated into independent colonies while Riveres du Sad was renamed as Colony of French Guinea

In 1975, Dahomey was renamed People's Republic of Benin Ivory coast changed her name to Cote d' Ivoire in 1986

Sierra Leon was called Sierra Leoa until the name was changed to Sierra Leon in 1787

Senegal was formerly called Upper Guinea by European traders.

The Republic of Liberia was previously called the Colony of the American Protectorate Society.

Ghana was known as the Gold Coast during Colonial era until 1957 when she regained her independence

Gambia's name changed from British Gambia to The Gambia when she regained her independence in 1965 and was changed again to the Islamic Republic of Gambia in 2015

So from the list of Nations in West Africa alone, NIGERIA is the only nation that is still bearing a Colonial name and this is an issue never raised before because some or all of the issues plaguing NIGERIA may be embedded in the name of exploitation and corruption and blood that stained the baton of power that was handed over to our Post colonial leaders because one of the major components of that baton was the name NIGERIA.

Nobody fully understands why and how these mysteries of name change work but it that has been a consistent pattern of action even by God Himself who changed the names of Abraham and his wife Sarah and scripture based stories of name change has been fully discussed in this chapter, why has NIGERIA failed to read the writing on the wall.

Nigerians cannot really understand NIGERIA. How can a country with so much surplus of crude oil and hundreds of other precious minerals and garnished with the best brains; how can we just be in the deplorable condition we find ourselves today. How and why is this possible? Could name change issue be part of the culprit to the problem?

I firmly believe name change is part of the problem we need to fix to begin to unlock hidden potentials in every sector of nation building and good governance.

You can observe from the map of West Africa below, and counting eastwards from Nigeria and in this order, that all these West African countries have had a dramatic change of national identity when the names of these Nations were changed; namely, of Benin Republic, Ghana, Cote d' Ivoire, Liberia, Sierra Leon, Guinea Bissau and Senegal.

Yes all these countries that belong to ECOWAS have all changed their country names.

The question begs. Why is NIGERIA the only isolated country still holding unto a name soaked in centuries of slavery, exploitation, corruption and bad governance? WHY IASK?



Nigeria is now sixty two years and in another 40 years, which will come faster than you can ever imagine, NIGERIA would be 100 years. The gospel truth is that if something dramatic does not occur in Nigeria, in another 40 years when NIGERIA will turn a hundred years, NIGERIA may be ten times worse than today and the leaders and people of NIGERIA at that time will say "but how did we get here".

#### CHAPTER 10 ISSUES ARISING FROM THE DRAFTING OF THE CONSTITUTION OF THE FEDRAL REPUBLIC OF NIGERIA

This book will be grossly incomplete without making reference to the

Constitution of the Federal republic of Nigeria because there are national issues, conversations and concerns surrounding the current state or drafting of the Constitution and until these areas of differences are sorted out in some kind of amendments to the Constitution, we may be paddling the NIGERIA boat against the river currents of discontent, marginalization, corruption and murmuring.

When a Nation is gripped in the throes of discontent, marginalization, corruption and murmuring, then it is just a matter of time and there will be a reciprocal action to the issues causing division. History does not lie and if we go down history lane we will see ample instances where a revolution was inspired as a direct result of having a Constitution that is begging for amendments.

Please refer to previous chapter one and pages nine to eleven for some insights into revolutions that took place in recent times and in this chapter, the Arab Spring/Revolution was triggered by similar dynamics and vibrations as we see playing out in Nigeria today.

Apartheid in South Africa became an official social, economic and political currency in 1910 and it took till 1990 when

apartheid collapsed and Mr. Nelson Mandela was released from prison after spending a whopping 27 years in Rubben Island prison.

There was growing resistance to the apartheid government in South Africa and nothing could ever stop the resistance that became very bloody and violent towards the waning days of the apartheid led government. The crust of the matter is apartheid finally collapsed and Nelson Mandela became the first Black president of South Africa.

There are other instances of uprisings in other parts of the world, but as the saying goes "charity begins at home" so let us keep our focus on similar situations that occurred in recent times in Africa namely the Arab Spring/revolution and the collapse of Apartheid. The lengthy war in Sierra Leon under the leadership of Charles Taylor is even a quite recent episode of discontent, corruption, marginalization and murmuring that almost totally destroyed that West African nation and while Charles Taylor is serving a life jail sentence for crimes against humanity, Sierra Leon is still rebuilding the destruction the war brought upon Sierra Leon and the human and natural resources including total destruction of vital infrastructure and utilities decades ago that are yet to be fully rebuilt.

To build a great Nation is so difficult, but to destroy as easy as ABC.

Let all well-meaning NIGERIANS take note, because if we take a cue from events in history in Africa that appear similar, one will easily detect that it is just a matter of time and there is bound to be an equivalent reaction to the issues causing discontent, marginalization, corruption and murmuring. It's happened before in history so what makes us think it will not happen again, but God forbid, NIGERIA takes that route, because we are smart people, but for the misguidance of our Colonial Masters we may very well be a very peaceful nation or community of Nations today just as we see many clusters of Sovereign Nations living in peace side by side in Europe. But it's never too late to make corrections and in this instance it is referred to as amendments to the Constitution of the Federal republic of Nigeria.

It is only commonsense to realize that to have lasting peace in any community, all parties have to agree in the articles of any Constitution and if there are any areas of differences, then such areas need to be ironed out amicably applying the spirit of compromise, tolerance and forgiveness.

This brings me to the dynamics that informed the drafting of the current Constitution because some articles of the Constitution are not at par with how it was actually executed on ground.

For instance, in page LL1 of the Constitution and paragraph 3 it states, "And Whereas the Constitution coordinating committee benefited from the receipt of large volumes of memoranda from NIGERIANS at home and abroad and oral presentations at the public hearings throughout the country and the conclusions arrived thereat and also at various seminars, workshops and conferences organized and was convinced that the general consensus of opinion of Nigerians is the desire to retain the 1979 Constitution of the Federal Republic of Nigeria with some amendments. "

Now there is a big problem to this article because as sweet as it sounds, that is exactly what never happened, because the involvement of the people that own the land was executed in a low key and shabby status.

Now bear in mind what has been discussed so far and allow your eyes to rest on page LL15 and paragraph one.

It states in caps "WE THE PEOPLE of the Federal republic of Nigeria HAVING firmly and solemnly resolved TO LIVE in unity and harmony as one indivisible AND indissoluble sovereign Nation under God."

Now flashback to what was claimed without a single shred of evidence that there was alleged receipt of large volumes of memoranda from NIGERIANS at home and abroad and you will see for yourself that the claim that intense Public participation of the owners of the land to The exclusion of none was purportedly executed, but if I was JUDGE of the high court and this kind of outrageous claim is brought before my Court, all I will say is show me evidence of such detailed owner-of- land intense participation and all the claims of Public hearings, seminars or workshops that transpired sequel to the DRAFTING or amending thereof the 1979 Constitution.

If evidence cannot be furnished directly from where this claim emanated from then the next reliable source of evidence is the internet and if there are no stories, reports or write-ups or even videos or photos on the internet concerning this purported high volume participation of the people that own the land, then this event of mass participation of the NIGERIA people to amend the 1979 Constitution never happened.

It never happened. PERIOD. If there was mass participation of Nigerians at home and abroad, where is the evidence?.









But check this out?

When you reflect on African Leadership, horrible things stand out.

Idi Amin, Emperor Bokossa, Charles Taylor, Robert Mugabe, Husseni Mubarak, Ghadaffi, Abacha and the list goes on and on with the exception of Nelson Mandela.

There must be more to this pattern than mere chance that begs for analysis and scrutiny.

### SPREAD OF TERRORISM

Pakistan is gripped by terror from the Taliban.

Kenya is watching over her shoulders, fearful of Alshabab attacks.

Iraq, Afghanistan, Libya and numerous nations strategize and re-strategize to keep Al Queada far from their lands.

Nigeria is groaning under the terror of Boko Haram.

America may be greatly smart at keeping all these extremist groups from their soils, but America is groaning, moaning and bleeding over senseless home grown shoot-out and terror, especially in schools, terrorism reigns supreme.

South Africa - Oh South Africa - Report says there is a murder somewhere daily. Violent and civil disobedience is ravaging the nation.

Armed robbers, Somalia kidnappers, luxurious bus hijacking, traffic jam bandits, sea pirates or ocean going pirates, common home burglars and armed robbers and market-pick-pockets are just as plentiful like sand in the sea.

The question is, what on earth is going on? Can anybody figure where on earth is safe?

#### WHEN A NATION LACKS CAPACITY

When a nation fails to put in place the necessary structuresinfrastructures- tink tanks research academies and institutions to harness, mobilise and harvest talent, academic and intellectual capacity or allows brain drain or the loss of the most brilliant minds that the nation has to offer to migrate to other nations - then that nation is like a mother with very thirsty children who goes down to the fresh water stream to fetch a pot of water but with tiny holes all over the pot, that by the time she returns with fresh water to quench the thirst of her dehydrated children, most of the water has leaked away from the pot then instead of the time she arrives to quench the thirst of her looking for a new non defective pot she returns to the stream with the same pot only to compound the problem of her thirsty childrensuch is the experience of many African Nations- we need to learn lessons from China and the West.

#### VOCATIONS, HANDY CRAFTS AND PROFESSIONS

God created man with the vocation of man upper most in His mind-Adam was created as a farmer and animal keeper to tend to the Garden of Eden-the first profession according to scriptures. There is dignity in labour and the glory of this dignity does not necessarily lie in the ability or inability of man to amass millions and millions of dollars. In numerous developed nations it is common to see a child say with so much conviction and pride-"I want to be a policeman or fire fighter or driver or teacher or mortuary attendant or even a road sweeper.." But in many developing nations this is not the case- the average child just wants to drive a big car and be rich-how he intends to achieve that is secondary- This was not in the original plan of God- that is the acquisition of money as the vocation- it has been put upside down and this is a global trend that must be nipped at the bud before it blossoms into a global epidemic- God implants a vocation into the soul of every person firstly, but it is the responsibility of the person to identify the vocation - cultivatenurture - and harvest that vocation with the assistance of the State. Acquisition of great wealth is not a vocation, instead it is the vocation that brings the harvest of some money- large or small.

This corruption of the mind has to be corrected.

When a nation fails to hear and respond with proactive solutions to the cries and weeping of her youths, children and young adults for a better social economic and political climate in. the form of reduced inflation, adequate medical and educational facilities and dispensation plus readily affordable energy in spite of the availability of vast oil reserves and other natural resources being harvested from the soils of that nation, then that nation could be compared to a mother married to a wealthy oil tycoon, but who prepares the cheapest, tasteless soups and stews for her children and sends her children to the cheapest public schools on the cheapest public buses with no shoes on their feet and old worn-out backpacks on their backs and no books inside.

#### **RICH BUT TERRIBLY POOR NATIONS**

There are some nations that are very rich in diamond and gold but the people of that nation are known to only dig the gold dust from deep in the earth - have never owned a gold ring or necklace- there are some nations very rich in oil and natural gas but electric power supply is unreliable and petrol in frequent shortage -Such nations can be compared to a man who buys a big fancy car but instead of being driven by a uniformed driver, the car owner I wearing the drivers uniform and driving the car while the driver is wearing the bosses suit and sitting in the owners corner- other nations grow cocoa but its people are only cocoa farmers and harvesters- have never enjoyed a cup of hot chocolate or eaten a bar of chocolate. This is an anomaly that must be fixed.

#### **POWER IN THE SPOKEN WORD**

There is great power in the blessings or curses of parents over their children. The Holy Books tell us that life and death are in the power of our tongue, Parents especially fathers must apply great restrain never to swear against or curse their children no matter the provocation because such words coming from parents can derail the destiny of a child forever. Instead parents should always remember to pronounce blessings upon their children regularly. A good time to pronounce blessings upon our children is when a child offers gifts to their parents, on birthday dates or when a child has done well in something.
